She said she liked the food. She specifically praised Meghan, the activities director, and recounted several off-site trips that she enjoyed. When we spoke, she was waiting for the Wii device to be activated so she could bowl. She was proud of her ability to bowl well. She said that management responds to issues raised by the Resident's Council. She said that, with very few exceptions, the residents she shares the facility with all get along quite well.</p> <p>The facility was very clean.</p>
