<p>Are there resident issues or topics that need follow-up or review at a later time or during the next visit?</p> <ul style="list-style-type: none"> -The single shower door does not close. The shower has exposed plumbing pipes; rust on inside of door frame and shower rod; wet pressed board cabinets. - The bathroom next to the shower needs grout by the toilet. -The second bathroom/tub combo needs grout by the sink. The tub does not appear to be in use since the drain appears to be plugged with a "plunger" in the tub. - Not all rooms have dressers for the number of beds in the rooms. 	<p>Discuss items from "Areas of Concern" Section as well as any changes observed during the visit.</p> <p>All items identified were shared with the available facility SIC and the County Ombudsman.</p>
