1. Project Overview

Land of Sky Regional Council (LOSRC), with funding from the Appalachian Regional Commission's ARISE initiative and other state and local partners, is seeking qualified firms or teams to support the implementation of regional forest products marketing and supply chain analysis. This effort will help revitalize the Southern Appalachian forest sector by addressing supply chain disruptions, market challenges, and opportunities for innovation.

The selected firm will support a multi-state task force in assessing market conditions, mapping supply chain assets, and identifying pathways for industry growth in pulpwoodusing product that have positive market growth forecasts, such as paperboard and paperboard packaging, composite board products, biochar, sustainable aviation fuel, textiles, and other forest-based products.

2. Background

This project responds to economic disruptions and natural disasters that have strained the region's forest products sector. The initiative aims to build economic resilience and regional competitiveness through strategic marketing, supply chain evaluation, and investment-attraction tools. Deliverables will guide future actions by regional stakeholders, including economic developers, private industry, and government agencies.

3. Scope of Work

This RFQ seeks qualifications for the following services:

- Supply Chain Mapping: Document and analyze existing forest product supply chains across the Southern Appalachian region, including:
 - Analysis of existing average annual net growth, harvest removals, average annual mortality, and current surplus net growth
 - Potential feedstock annual supply forecast based on growth & yield modeling over a 30-to-40-year planning period
 - Forest Resources Modeling and Analysis (i.e. Subregional Timber Supply, Forest Inventory Analysis)
- Market Research & Analysis: Evaluate current and emerging markets (e.g., packaging paper & paperboard, composite board, biochar, SAF, textiles), including workforce feasibility, demand trends, barriers, and competitive positioning.
- Strategic Marketing Recommendations: Inform a marketing strategy to promote regional forest products and attract private investment.
- Stakeholder Engagement: Facilitate input from forest sector businesses, industry groups, landowners, and economic development entities.
- Pitch Deck & Investment Materials: Support the creation of materials to promote the region's value proposition for green innovation and investment.
